#### President Sherman:

- VP of DEI Gig Secuban has accepted a position at Texas State University. Interim Director: Dr.
   Salome Nnoromele, for two years. She has extensive administrative background and significant work in DEI.
- Candidates for VP of Finance and Administration visiting campus this week.
- VP Student Affairs, ads published, determining the finalist pool so they can visit before the end of the semester.
- Board of Trustees meeting Thursday and Friday. Main subject is the approval of budget for next fiscal year. Enrollments looking positive. Budget assumes 2% raise pool, and future budgets also assume regular raises.
- Transition of Board leadership: Peggy Viehweger taking over as Chair in July. Currently one trustee short, in July Trustee Coleman steps down and we will be two short.
- International Week next week.

#### Provost Sayrs:

- Ramadan started Saturday, please be aware your students who observe may need a little more support. Ramadan lasts through the end of the semester.
- State low enrollment course and program report: approaching next 5-yr cycle. Report due in September. State provides a list of "potentially duplicated" programs, and we provide list of low-enrollment courses. Team will be working through the summer.
- Dean Search updates: Nicole Pennington stepping down. Request for nominations will be sent out for interim role.
- Patton College and CHSP: Searches gearing up, faculty ballots have been sent out.
- VPFA, second candidate rescheduled due to illness.

## Questions:

Senator: President Sherman, RHE Faculty are excited to see the Regional Promise. However, RHE budgets are separate from Athens and saw impacts even before COVID started. This year the money associated with our most prestigious teaching award has disappeared. How are we funding this initiative, and is this temporary or permanent?

President Sherman: The promise scholarship is something we think will be very effective and we have the opportunity to expand it. It is a test project to tackle affordability for our students. If it is successful and generates enrollment, we can expand. Also developing another capital campaign. One of the key focuses will be scholarship money for students. Our goal is to expand enrollment at the regional campuses.

Senator: Can you address how you plan to address racial incidents and racial climate on campus in light of the transition of the VP of DEI.

President Sherman: I don't think we will lose momentum, we will continue to work on the steps we have committed to and we have overlap for the transition. We committed to bring in a nationally recognized expert on DEI to do a complete audit on policies and procedures. It's not one person's job, it is the commitment of everyone. I'm saddened by the recent events and we want this place to be inclusive and supportive of every student.

- 1. Capital Projects
  - Replace Peden turf was approved at \$1.3M, but President Sherman noted that the General Fund is not a good way to fund these items and there should be a procedure for ICA to fund these items.
  - Stocker Center Renovation Issue delayed so Provost has time to review.
  - Benefits Advisory Council:
    - o Insurance rate premiums will run higher than projected
    - Contract with Anthem comes up for renewal. RFP to be issued, including for an RFP to provide a broader catalog of plans. Committee to work on this over the summer.
    - o STRS/ARP mitigating rate will go down to 2.9% effective July 1st.

Senator: Please encourage the BAC to look at a broad array of options because the premium increases are considerably higher than expected.

Chair Muhammad: BAC is an advisory committee which brings together constituencies, but decisions are made by Total Compensation Committee.

Senator: RFP committee will go beyond the BAC and include more voices.

New business

Senator: might there be an appetite to move these meetings to an earlier time to avoid late nights?

Chair Mohammad: this is a conversation we can and probably should have. It should be taken up by Senate leadership.
