Please use the full legal name you used during your previous enrollment. If your name has changed, please attach the [appropriate legal document](#) to request a name change (passport, court action document, divorce decree, marriage certificate).

If you have enrolled at another college or university, since you were at OHIO, it must be reported. Failure to do so is grounds for terminating enrollment. If you are re-enrolling as an undergraduate student, you must have an official transcript from any institution attended sent to the [Office of Undergraduate Admissions](#), Chubb Hall 120, Athens OH 45701, 740.593.4100, admissions@ohio.edu. If you are re-enrolling as a graduate student, you must have an official transcript from any institution attended sent to the [Graduate College](#), Grosvenor Hall 102, Athens OH, 740.593.2800, graduate@ohio.edu.
