Students enrolled in a graduate degree program at another regionally accredited institution may apply for transient status to take graduate courses. Transient status is granted for one quarter; you must request permission each quarter to register at Ohio University as a transient student. A transient student who wishes to enroll for additional quarters beyond the initial quarter of admission must do the following: 1) File a new Graduate Transient Student Application and Certification of Good Standing with Graduate Studies and 2) pay a \$25 re-application fee. Reentry must be approved by the academic department and Graduate Studies to be official. Transient students are not eligible for OU graduate assistantships, fellowships, or OGS stipend/scholarships.
