## Residency Questionnaire

The Residency Questionnaire is provided to assist you in determining if you **may** qualify for in-state tuition based on law established by the Ohio legislature. Official residency decisions are made by Undergraduate Admissions and the Graduate College only after the receipt of an official residency application and supporting documentation.

<p>1. Are you a graduate of an Ohio high school?</p>	<p><input type="checkbox"/> Yes. You may qualify for reclassification under the "Forever Buckeye" or C-8 provision.</p> <p><input type="checkbox"/> No. Proceed to question 2.</p>
<p>2. Have you, your parent/legal guardian, or spouse been a resident of one of the following Kentucky counties (Boyd, Carter, Elliot, Fleming, Greenup, Lawrence, Lewis, Mason or Rowan), consecutively for the past 12 months?</p>	<p><input type="checkbox"/> Yes. You may qualify for Kentucky Tuition Reciprocity agreement (Athens and Southern campuses only).</p> <p><input type="checkbox"/> No. Proceed to question 3.</p>
<p>3. On whom are you financially dependent? Who provides at least 51% of your financial support? (Please select only one.)</p>	<p><input type="checkbox"/> Self. Proceed to question 4.</p> <p><input type="checkbox"/> Parent(s) or legal guardian. Go to question 5.</p> <p><input type="checkbox"/> Spouse. Proceed to question 5.</p> <p><input type="checkbox"/> Other. Proceed to question 5.</p>
<p>4. Are you currently on active duty or a veteran of the United States military?</p>	<p><input type="checkbox"/> Yes. Proceed to question 7.</p> <p><input type="checkbox"/> No. Proceed to question 15.</p>
<p>5. Will you be domiciled in Ohio prior to the start of the semester?</p>	<p><input type="checkbox"/> Yes. Proceed to question 6.</p> <p><input type="checkbox"/> No. Proceed to question 11.</p>
<p>6. Is the person checked in Question three on active duty or a veteran of the United States military?</p>	<p><input type="checkbox"/> Active to question 11.</p> <p><input type="checkbox"/> Veteran to question 8.</p> <p><input type="checkbox"/> No. Proceed to question 17.</p>
<p>7. Are you an active duty military person or a veteran?</p>	<p><input type="checkbox"/> Active duty. You may qualify for the E-2 Exemption if you are a legal resident of Ohio (but stationed somewhere else) or the E-3 exemption if you are stationed in Ohio.</p> <p><input type="checkbox"/> Veteran. Proceed to question 10.</p>

8. Is the veteran on whom you are dependent a resident of Ohio?	<input type="checkbox"/> Yes. If yes, you may qualify for the C-4 rule. <input type="checkbox"/> No. If no, proceed to question 9.
9. Are you utilizing transferred military benefits from the veteran on whom you are dependent?	<input type="checkbox"/> Yes. If yes, you may qualify under the C-6 rule <input type="checkbox"/> No. If no, proceed to question 11.
10. Are you a qualified military service member or veteran using educational assistance under Chapter 31 (Vocational Rehabilitation and Employment), who will be living in the state of Ohio before the first day of classes?	<input type="checkbox"/> Yes. You may qualify for the C-7 rule. <input type="checkbox"/> No. You may qualify for the C-4 or C-5 rule.
11. Is the person checked in Question three a member of the Ohio National Guard?	<input type="checkbox"/> Yes. You may qualify for the E-8 exception. <input type="checkbox"/> No. Proceed to question 12.
12. Is the person checked in Question three on active military duty both stationed and residing in Ohio?	<input type="checkbox"/> Yes. You may qualify for the E-3 exception. <input type="checkbox"/> No. Proceed to question 13.
13. Is the person checked in Question three a current Ohio resident serving in the military?	<input type="checkbox"/> Yes. You may qualify for the E-2 exception. <input type="checkbox"/> No. Proceed to question 14.
14. Is the person checked In Question three described by one of the following?: (a) a veteran who resided in Ohio on the first day of the term for which you are applying for in-state residency and either served one or more years on active duty and was honorably discharged or received a medical discharge due to military related service or (b) the spouse or dependent of a deceased veteran or a or a veteran who has been declared missing in action or a prisoner of war?	<input type="checkbox"/> Yes. You may qualify for the C-4 rule. <input type="checkbox"/> No. Based on the answers you provided above, you are not eligible for in-state residency. You may be eligible if you are a part-time student under Residency Exception E-1 or wait 12 months and reapply.
15. Will you be a part-time or full-time student? (Part-time is defined as an undergraduate student taking less than 12 credit hours per term and for a graduate student taking less than 6 credit hours per term. Full-time is an undergraduate student taking at least 12 credit hours per term and a graduate student taking at least 8 credit hours per term.)	<input type="checkbox"/> Part-time. You may qualify for the E-1 exception. <input type="checkbox"/> Full-time. Proceed to question 16. <input type="checkbox"/> No. Proceed to question 24
16. Have you lived in Ohio consecutively for the past 12 months?	<input type="checkbox"/> Yes. You may qualify for the C-2 rule. <input type="checkbox"/> No. Proceed to question 18.
17. Did the person checked in Question three claim you for tax purposes in the previous tax year (parent/legal guardian/spouse)?	<input type="checkbox"/> Yes. Proceed to question 18. <input type="checkbox"/> No. Based on the answers you provided above, you are not eligible for instate residency. You may be eligible if you are a part-time student under Residency Exception E-1 or wait 12 months and reapply.

<p>18. Has the person checked in Question three been living in Ohio consecutively for the past 12 months?</p>	<p><input type="checkbox"/> Yes. You may qualify for the C-1 rule.</p> <p><input type="checkbox"/> No. Proceed to question 19.</p>
<p>19. Did the person checked in Question three accept full-time, self-sustaining employment and establish domicile in the State of Ohio for reasons other than the benefit of favorable tuition rates before the first day of the term?</p>	<p><input type="checkbox"/> Yes. You may qualify for the C-3 rule.</p> <p><input type="checkbox"/> No. Proceed to question 20.</p>
<p>20. Is the person checked in Question three currently an Ohio resident who has been transferred by the employer beyond the territorial limits of the United States and has satisfied his/her Ohio tax obligation?</p>	<p><input type="checkbox"/> Yes. You may qualify for the E-4 exception.</p> <p><input type="checkbox"/> No. Proceed to question 21.</p>
<p>21. Is the person checked in Question three a migrant worker who has been employed in the state of Ohio at least four months during the three years preceding the proposed enrollment?</p>	<p><input type="checkbox"/> Yes. You may qualify for the E-5 exception.</p> <p><input type="checkbox"/> No. Proceed to question 22.</p>
<p>22. Is the person checked in Question three a community service worker – an Ohio resident who took a position working for the Peace Corps, AmeriCorps or similar program as determined by the Ohio Board of Regents, or an elected or appointed public official who lives outside Ohio for a period of time not exceeding 24 consecutive months returns to Ohio?</p>	<p><input type="checkbox"/> Yes. You may qualify for the E-6 exception.</p> <p><input type="checkbox"/> No. Proceed to question 23.</p>
<p>23. Is the person checked in Question three a person who has returned to Ohio, who has taken legal steps to end a marriage and reestablish financial dependence upon a parent or legal guardian who is an Ohio resident?</p>	<p><input type="checkbox"/> Yes. You may qualify for the E-7 exception.</p> <p><input type="checkbox"/> No. Based on the answers you provided above, you are not eligible for in-state residency. You may be eligible if you are a part-time student under Residency Exception E-1 or wait 12 months and reapply.</p>
<p>24. Have you, or the person on whom you are financially dependent, returned to the state of Ohio due to marital hardship, taken legal steps to end a marriage, or re-established financial dependence upon a parent or legal guardian (receiving greater than 50% of support from the parent or legal guardian)?</p>	<p><input type="checkbox"/> Yes. You may qualify for the E-7 exception.</p> <p><input type="checkbox"/> No. Based on the answers you provided above, you are not eligible for in-state residency. You may be eligible if you are a part-time student under Residency Exception E-1 or wait 12 months and reapply.</p>
