# Tier II

You are required to complete a total of 21 credit hours from an approved list of courses in the following six distribution areas:

Applied Science and Mathematics	MATH 1350 is required for BSM and meets this requirement	
Cross Cultural Perspectives	Choose any course from Cross Cultural list (see DARS)

Humanities and Literature	COMS 1030 is required for BSM and meets this requirement	
Natural Sciences	Choose any course from Natural Science list (see DARS)

You are required to take at least one course in each of the six areas and may satisfy no more than two of the required six areas with courses from the same department/school. You may satisfy no more than 8 of the 21 hours with courses from the same department/school.

#### TIER III

SASM 4500 is required for the Sport Management major and also meets the TIER III requirement.

BUSINESS CLUSTER: includes the following four courses: BA 2500 (3), MGT 2100 (3), MIS 2020 (3), MKT 2400 (3)

Prerequisites: BA 1000, BA 1100, BA 1500, UC 1900 OR 1500, ACCT 1010, ENG 1510 OR 1610.

NOTE: FIN 3000 must be completed prior to or along with the Business Cluster.

**DIRECTIONS TO REGISTER:** Using the on-line registration system, load all four cluster courses in your "shopping cart" <u>before</u> you click "finish enrolling". If you have not already complete FIN 3000, put that in shopping care too. Note: For your convenience, corresponding courses and the course number for each course will be listed in parenthesis on the course offerings website. Remember, you cannot mix courses from different cluster sections.

**CLUSTER WAITING LIST**: If all sections of the Business Cluster are full when it is your time/day to register, take two immediate actions:

- 1) Register for the best possible schedule of courses in case you do not get a seat from the waiting list (this is very important)
- 2) Visit the CoB Office of Student Services in 214 Copeland Hall to find out how to have your name added to the waiting list. The CoB holds back a number of seats for the waiting list. These seats are typically released according to seniority.

**ADVISING IN THE COLLEGE OF BUSINESS**: It is important to know that every business major will have a REGISTRATION HOLD on their account every semester that will keep them from registering for next-semester courses until they have participated in a CoB advising activity. Activities will vary by year of entry. Instructions will be e-mailed to student's e-mail address prior to each registration period. Registration holds will be released with 72 hours of the date of the advising activity attended.
