

- 1. Go to online Course Offerings at the following URL: https://webapps.ohio.edu/classes/search.htm
- 2. Choose the correct semester
- 3. Under "General Education Requirements", choose the Tier II category
- 4. Click "Search"

You are required to take at least one course in each of the six areas and may satisfy no more than two of the required six areas with courses from the same department/school. You may satisfy no more than 8 of the 21 hours with courses from the same department/school.

You may apply no more than two approved Tier II courses in your major department/school or area of concentration (for B.S.S. students) toward partial fulfillment of the Tier II requirement

SASM 4500 meets this requirement and is required for the Sport Management major.

OTHER HELPFUL INFORMATION

BUSINESS CLUSTER

Includes the following four courses: BA 2500 (3), MGT 2100 (3), MIS 2020 (3), MKT 2400 (3)

Prerequisites: COB, BA 1500, ECON 1030, ENG 1510 OR 1610.

DIRECTIONS TO REGISTER: Using the online registration system, load all four cluster courses in your "shopping cart" <u>before</u> you click "finish enrolling". **NOTE:** For your convenience, corresponding courses and the course numbers for each course are listed in parenthesis on the course offerings website. Remember, you cannot mix courses from different cluster sections.

CLUSTER WAITING LIST: If all sections of the Business Cluster are full when it is your time/day to register, take two immediate actions:

- 1) Register for the best possible schedule of non-Cluster courses in case you do not get a seat from the waiting list (this is very important)
- 2) Visit the COB Career & Student Success Center in 214 Copeland Hall to find out how to have your name added to the waiting list. The COB holds back a small number of seats for the waiting list. These seats are typically released according to seniority.

ADVISING IN THE COLLEGE OF BUSINESS

Every business major will have a REGISTRATION HOLD on their account every semester until they have participated in the appropriate COB registration activity with the Academic Advising team. Instructions are emailed each semester prior to the registration period. These registration activities are based on academic milestones. Registration holds will be released within 72 hours of completion of the registration activity. It is the student's responsibility to be aware of the registration activity and to attend the appropriate event.
