#### AREA OF EXPERTISE

I am a critical-cultural communication scholar whose primary research aims to shed light on the power and politics of gender in organizing. Broadly, my research, teaching, and community involvement all focus on the politics of epistemologies—exposing, dismantling, and reclaiming through communication for the purposes of bringing about social change. I utilize qualitative methods (informed by rhetorical sensibilities and postmodern feminist theory) to conduct research that is anchored in engaged work and applied results. My scholarship focuses on three overarching questions: How does gendered organizing create subjectivities?... police behavior?... and affect access to resources across communities? Past projects have also taken on an interdisciplinary spirit, spanning organizational, interpersonal, and instructional divisions. I teach courses in gender and communication, organizational communication, and qualitative research methods at both undergraduate and graduate levels and I am a certified facilitator with *The Institute for Civil Dialogue*(R) and *StoryScope: A Story Circles Project*, which I have utilized in both classroom and community spaces.

I pursued certification in the interest of teaching and advising—these skills make me better equipped to respond to students' mental health challenges, which have increased since the COVID-19 pandemic. In May 2023, I sought continuing education by attending an MHFA "Lunch 'N Learn" event with OHIO Assistant Clinical Professor, Janice Wright, titled, "If you See Something, Say Something: Effective Interventions for Microaggressions."
