All advisor updates, change of program, DARS exceptions, and transfer course equivalencies should be completed before that time. It is anticipated that the printed DARS reports (for those requesting them) will be delivered by the end of the work day on Monday, March 11. An updated DARS report will be available through the Faculty and Advising Center for all students enrolled for Spring Semester.

A complete semester version of the DARS report will be available to undergraduate students enrolled in any major offered by the following colleges:

Arts & Sciences  
Business  
Communication  
Health Sciences and Professions  
Regional Higher Education  
University College

A complete semester version of the DARS report will be available to undergraduate students enrolled in a limited number of majors offered by the following colleges:

**Education (limited to majors offered by the Department of Human & Consumer Sciences  
Education and the Department of Recreation & Sport Pedagogy)**

**Engineering and Technology (limited to the Mechanical Engineering major)**

**Fine Arts (limited to the Bachelor of Arts majors offered in Art and Art History)**

An abbreviated version of the DARS report (general education only) will be available to undergraduate students who are enrolled in a major that has not yet been fully encoded to reflect the semester curriculum.

A complete semester version of the DARS report will be available to undergraduate students enrolled in most undergraduate minors and certificates.

Providing a complete semester version of the DARS report for undergraduate students is a priority for staff from the Office of the Registrar. We will continue to make these available through the Faculty and Advising Center as they are developed.
