

# Citizenship Documentation Request Form 2024-2025

Complete the form as instructed below. The original Ohio University citizenship documentation request form and copy of proof of citizenship, as described below, must be mailed to or dropped off at the Office of Student Financial Aid and Scholarships or at a regional campus Student Services Office. Photocopies or faxes of this form will not be accepted.

Present the original proof of citizenship document in person at the Office of Student Financial Aid and Scholarships or at a regional campus Student Services Office where a photocopy will be made. Alternative option for students or individuals who are unable to appear in person, present their documentation in the presence of a notary of their choice. The Notary will verify the original citizenship documentation you provide and complete the Notary's Certificate of Acknowledgement. Return the original notarized Citizenship Request form plus a copy of their proof of citizenship used with the Notary to the Office of Student Financial Aid and Scholarships. Acceptable documentation is listed below.

If you are in the U.S. only on an F1 or F2 student visa, a J1 or J2 exchange visitor visa, or a series G visa (pertaining to international organizations) you are not eligible for federal, state, or institutional aid through the Office of Student Financial Aid and Scholarships at Ohio University.

## **Acceptable Documentation**

#### U.S. Citizen:

- Birth certificate, if born in the United States, Puerto Rico, Guam, U.S. Virgin Islands, American Samoa, Swain's Island, or Northern Mariana Islands
- Valid U.S. passport, current or expired, except limited passports
- Form N-560 or N-561 (Certificate of Citizenship)
- Form N-550 or N-570 (Certificate of Naturalization)
- Form FS-240 (Consular Report of Birth Abroad)
- Form FS-545 (Certificate of Birth-Foreign Service)
- Form DS-1350 (Certification of Report of Birth)

### Eligible Non-citizen:

- Form I-551 (Permanent Resident Card)
- Form I-551C (Conditional Permanent Resident Card)
- Form I-94 (Arrival-Departure Record) with any one of the following designations:
  - A) Refugee
  - B) Asylum Status
  - C) Parolee (minimum of one year and status has not expired)
  - D) T-Visa holder (T-1, T-2, T-3, etc.)
  - E) Cuban-Haitian Entrant
