CERTIFICATE OF DEPENDENCY FORM

2. The University Registrar may require that you submit official documentation such as income tax statements, receipts of expenditures, etc., as proof that you qualify as a parent/guardian of a dependent student, as defined by the Internal Revenue Code of 1954.
3. Grades for the dependent student will be mailed to the name and address of the person filing this certificate.
4. For any future transcript or class schedule requests, please include a copy of this Certificate of Dependency form and enclose the proper payment with the written request.
5. The dependent student will be notified via e-mail that a Certificate of Dependency form has been received.
6. Ohio University will assume that the dependency status of this student has not changed unless otherwise notified in writing by the person submitting this Certificate of Dependency form or the student.
7. A student has the legal authority to sign and submit a Certificate of Non-Dependency form to the Office of the University Registrar indicating that he/she is no longer a dependent of the parent/guardian for federal income tax purposes. Once this certificate is on file in the Office of the University Registrar, the grades will no longer be sent to the parent/guardian of the student.
