AN ORDINANCE AMENDING ATHENS CITY CODE, TITLE 9, GENERAL REGULATIONS, CHAPTER 9.15, PARKS, OPEN SPACES, AND NATURE PRESERVES, SECTION 9.15.02, USE OF TOBACCO, TOBACCO PRODUCTS, OR TOBACCO DERIVATIVES PROHIBITED; AND TITLE 13, GENERAL OFFENSES, CHAPTER 13.07, MISCELLANEOUS OFFENSES, SECTION 13.07.06, LITTERING PUBLIC WAYS.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATHENS, OHIO:

SECTION 1: The Athens City Code, Title 9, General Regulations, Chapter 9.15, Parks, Open Spaces, and Nature Preserves, Section 9.15.02, Use of Tobacco, Tobacco Products, or Tobacco Derivatives Prohibited, shall be amended to read as follows:

Chapter 9.15. Parks, Open Spaces, and Nature Preserves

9.15.02. DEFINITION.

“USE OF ANY FORM OF TOBACCO” MEANS ALL USES OF TOBACCO, INCLUDING INHALING, EXHALING, BURNING, OR CARRYING ANY LIGHTED CIGAR, CIGARETTE, PIPE, OTHER LIGHTED SMOKING DEVICE OR PAPERS FOR BURNING TOBACCO, OR ANY OTHER PLANT; CHEWING TOBACCO, SNUFF, OR ANY OTHER MATTER OR SUBSTANCES THAT CONTAIN TOBACCO.

9.15.03. USE OF TOBACCO, TOBACCO PRODUCTS, OR TOBACCO DERIVATIVES PROHIBITED.

(A) NO PERSON SHALL USE ANY FORM OF TOBACCO AT OR ON ANY CITY-OWNED OR OPERATED OUTDOOR RECREATIONAL FACILITIES, INCLUDING PARKING AREAS, RESTROOMS, SPECTATOR, AND CONCESSION AREAS. OUTDOOR RECREATION FACILITIES INCLUDE PLAYGROUNDS, ATHLETIC FIELDS, AQUATIC AREAS, PARKS, PAVILIONS, SHELTERS, AND WALKING/HIKING TRAILS OR PATHS.

9.15.04. POSTING OF SIGNS.


(A) CITY-OWNED OR OPERATED OUTDOOR RECREATIONAL FACILITIES SHALL CAUSE TO BE CONSPICUOUSLY POSTED "TOBACCO-FREE", "NO SMOKING", OR "SMOKING PROHIBITED" SIGNS AT THE ENTRANCE TO EACH SUCH FACILITY.

SECTION II: The Athens City Code, Title 13, General Offenses, Chapter 13.07, Miscellaneous Offenses, Section 13.07.06, Littering Public Ways, shall be amended to read as follows:


13.07.06. Littering public ways.

No person shall place or dispose of in any manner any garbage, waste, or peelings of vegetables or fruits, rubbish, ashes, cans, bottles, wire, paper, cartons, boxes, parts of automobiles, wagons, furniture, glass, oil, **TOBACCO PRODUCTS** or anything else of an unsightly or unsanitary nature along or near or on any public road, street, parkway, park, drive, highway, ditch, or any land adjoining any public road or highway or ditch, except on land provided by a zoning commission, city ordinance, or other governmental authority, unless directed to do so by public officials on special cleanup days. Citations for violations of this section may be issued by code enforcement officers, police officers, meter attendants, sanitarian litter control officer, and others assigned by the service-safety director.

SECTION III: This Ordinance shall be in full force and effect at the earliest moment permitted by law upon its passage and approval by the Mayor.
