

MINUTES OF THE MEETING OF
THE BOARD OF TRUSTEES OF OHIO UNIVERSITY

2:30 P.M., Monday, January 10, 1972
Chubb Hall, Athens, Ohio

I. Roll Call

The meeting was called to order by Chairman Baxter. Roll call showed a quorum to be present, consisting of Duncan M. Baxter, Chairman, Don M. Casto, Jr., Charles E. Holzer, Jr., Fred H. Johnson, Edwin L. Kennedy, William R. Morris, and Mrs. J. Wallace Phillips. Absent were Wayne M. Brown and C. Paul Stocker. Also present were President Claude R. Sowle and Secretary of the Board Robert E. Mahn. All other Senior Administrators were present--Vice President and Dean of Faculties Taylor Culbert, Vice President for Administrative Services W. Charles Culp, Vice President for Regional Higher Education Beaumont Davison, Vice President for Development Martin L. Hecht, Vice President and Treasurer John F. Milar, Associate Vice President and Dean of Faculties Edward M. Penson, Vice President for Educational Services Maxwell M. Pullen, and Assistant to the President for Planning, Budgeting and Information Services Robert L. Savage. Dean Don M. Flournoy, University College, Dean Harry Morgan, Afro-American Affairs, and Assistant Dean of Faculties for International Studies Norman Parmer, were in attendance to present reports.

II. Action on Minutes of November 8, 1971

The motion by Mr. Morris, with second by Mrs. Phillips, to approve the minutes of November 8, 1971, was adopted unanimously.

III. Communications, Petitions, and Memorials

None were presented.

IV. Reports of President and Senior Administrative Officers

President Sowle had no report. He introduced Dr. Culbert.

- A. Vice President and Dean of Faculties Taylor Culbert, Promotion and Tenure Procedures; Introduction to Reports by Deans Parmer, Morgan, and Flournoy (followed by introduction of each dean for his presentation).

Dr. Culbert reminded Board members that two years ago they had entrusted to the Administration the faculty promotion-tenure responsibility. This, he said, was a report on how this responsibility was being met. He asked them to note, in the sample files presented, the emphasis on teaching as a consideration. Forms are being revised to produce even a better evaluative procedure.

Following his presentation Dr. Culbert introduced, in turn, Deans Parmer, Morgan, and Flournoy for reports on what he characterized as interesting, significant and unique units in our organization.

1. Dean Parmer

Dean Parmer outlined the principal responsibilities and activities of the Office of International Studies. The office is organized into four divisions: The Center for International Studies, International Academic Services, Study Abroad Programs, and the International Student Advisor's Office. The Center is the largest and most important of the four divisions, inasmuch as it has undergraduate and graduate degree programs, enrollments in 1970-71 in excess of 3,000 students and has some 70 faculty members from 19 departments and 6 colleges associated with it. The International Academic Services Division is responsible for the administration of AID contracts overseas and while this activity is diminishing, the Office of International Studies continues to have an interest in possible future contracts for rendering services abroad. Student interest in the Study Abroad Program is very substantial, but tight money conditions have reduced students' ability to participate in such programs, particularly those in Africa and Asia where air fares are high.

The International Student Advisor's office currently administers to some 410 foreign students which represents a leveling-off in the rapid annual increases in the foreign student body at Ohio University over the past several years.

Dr. Parmer concluded by pointing out that he and his colleagues responsible for administering international programs and activities are all faculty members teaching at least half time.

2. Dean Morgan

Emphasized by Dean Morgan was the Black Studies Institute which provides a curriculum for the degree in Black Studies. Programs of the Institute place emphasis on Blacks as involved in the general development of cultural areas, for example, as opposed to making heroes of them.

In response to questions, Dean Morgan said that the University has 1,300 Black students. Counselors see 800 students each quarter. Institute courses are taken by 600 students, 60 per cent of them Whites. There are 15 majors. Dean Morgan reported that the Black Studies Institute was the first anywhere to graduate a student with a baccalaureate degree, that it probably is the healthiest in the country, and that because of the cooperative approach that prevails here, we are sought out for information and guidance by other institutions.

Our large percentage of Blacks results from Ohio University's reputation for amenability to minority groups. We have more Blacks than 35 per cent of the Black schools in the country.

3. Dean Flournoy

Assistant Dean James A. Hartman assisted Dean Flournoy in a simulation of the University College's counselor program, as it relates to the College's specific programs and all facets of the overall University program. Its specific functions are categorized under four headings: Administrative and Records Keeping, Academic Advising and Counseling, Direct Teaching, and General Coordination responsibilities for a number of University-wide programs.

In response to questions, Dean Flournoy stated that a much greater percentage of students still go through traditional rather than innovative programs.

Dean Flournoy distributed an Outline of Functions of the College, a January 1972 Status Report, and Bulletin. These are filed in the January 10 meeting folder.

B. Vice President and Treasurer Milar, Financial Report--Current.

President Sowle introduced Vice President and Treasurer Milar for a report on the current financial situation. Mr. Milar stated his belief that budget commitments can be met with projected income. Separate funding for the civil service increase had been hoped for, but appears unlikely. This will impose a considerable strain on the budget, but will be covered.

V. Unfinished Business

There was no unfinished business.

VI. New Business

A. Ratification of Associate Professor of Journalism Emeritus Status
Accorded Paul H. Wagner by mail poll completed December 9, 1971.

Mr. Mahn presented the following resolution which Mr. Kennedy moved for adoption. Mr. Morris seconded the motion, which was unanimously approved. (Documents related to the Resolution appear as Attachment 1.)

Resolution 1972-1

BE IT RESOLVED by the Board of Trustees of Ohio University that Paul H. Wagner is elected Associate Professor Emeritus of Journalism upon his retirement from the University as of the close of the Fall Quarter 1971-72 on December 11, 1971.

B. Approval of Appointments to Regional Councils.

Vice President Davison presented the following resolution and accompanying roster of nominees, approval of which was moved by Mrs. Phillips. Mr. Casto seconded the motion, which was approved unanimously. Along with the roster, Dr. Davison presented a brief biographical sketch of each nominee. (See Attachment 2.)

President Sowle stated that Council By-Laws provide for each Council Chairman to prepare and transmit to the Board through the Vice President for Regional Higher Education and the President, an annual report on or before May 30. Mr. Baxter expressed the opinion that the Council plan would provide much better communication than had been experienced previously.

C. Dormitory and Dining Financing.

Mr. Milar stated that it was the recommendation of the Administration that we proceed to long-range financing of the South Green dormitory and dining system under a broad base general receipts concept of financing. In order that planning might proceed, he presented for consideration the following resolution. Mr. Morris, as Chairman of the Budget, Finance and Physical Plant Committee, moved the adoption of the resolution. Dr. Holzer seconded the motion, which was adopted unanimously.

Resolution 1972-3

WHEREAS in anticipation of issuing \$24.8 million of bonds to accomplish the permanent financing of the South Green, the Mill Street Married Student Housing, the Commissary and the Laundry; the Committee on Budget, Finance and Physical Plant of the Board is hereby authorized, if it deems necessary, to select and employ a financial advisor to the University for this contemplated issue.

In response to questions, Mr. Milar verified that the \$24.8 million bond issue would be historic as the largest single issue of any kind by a university in Ohio. He stated that the Administration was recommending no increase in room and board rates for 1972-73. This will be brought to the Board when the budget is presented.

President Sowle reminded members that a \$90 increase in room and board rates had been contemplated for next year. It is good news that this probably will not happen.

- D. Readmission of Thomas L. Thomas as a Student (suspended under provisions of H.B. 1219).

In the absence of Mr. Stocker, who had, at the request of Chairman Baxter, interviewed Mr. Thomas, Dr. Holzer explained that Mr. Stocker and the Board Administration Committee recommended the readmission of Mr. Thomas. He moved adoption of the following resolution, which was seconded by Mr. Kennedy, and approved unanimously.

Resolution 1972-4

BE IT RESOLVED by the Board of Trustees of Ohio University that Thomas L. Thomas, a suspendee under provisions of H.B. 1219, be readmitted to the University effective the Spring Quarter 1971-72, the opening date of which is March 27, 1972, said student to be readmitted on probation, which probation status shall be effective for one year following readmission.

Chairman Baxter termed this a historic act, the first reinstatement of a 1219 suspendee. He expressed the hope that things would work out well for this young man. (Documents related to the Resolution appear as Attachment 3.)

- E. Report of Examination of Auditor of State: Report submitted by H. I. Graham, State Examiner, for the period July 1, 1969, to June 30, 1970.

Mr. Milar reported that no exceptions to the Financial Report had been made by the Auditor. The Chairman directed that the minutes reflect that the Report had been received by the Board and filed. (Attachment 4 constitutes the summary of the Audit Report.)

- F. Financial Report for the Fiscal Year Ended June 30, 1971 (previously distributed).

The Chairman directed that the minutes reflect that the Report had been received by the Board and filed. (A copy is filed in the January 10 meeting folder.)

- G. State Highway Department Request for Right of Entry.

Vice President Culp presented the following resolution, adoption of which was moved by Mr. Morris, Chairman of the Budget, Physical Plant and Finance Committee. Mr. Kennedy seconded the motion, which was unanimously approved. (The letter from Mr. Culp to President Sowle explaining the request appears as Attachment 5.)

Resolution 1972-5

WHEREAS, the State of Ohio, Department of Highways, has requested right of entry to certain lands owned by the Ohio University for the purpose of constructing a highway thereon and incidental facilities thereto, and

WHEREAS, this right of entry is to be granted pending the completion of negotiations with regard to compensation and damages for the subject parcels of land, and

WHEREAS, it is the desire of the State Department of Highways to obtain approval for right of entry at the earliest possible date to allow the agency to make application for Federal aid for financing portions of the construction, and

WHEREAS, Ohio University has not completed its investigation of the right of entry requests and desires to grant the same as soon as investigations have been completed,

NOW, THEREFORE, BE IT RESOLVED that the Board of Trustees of Ohio University do hereby authorize the Budget, Finance and Physical Plant Committee of the Board of Trustees to execute said right of entry agreements when investigations have been completed.

H. Resolution Concerning Educational Television Facilities.

Dr. Davison presented for consideration the following resolution. Obtaining the equipment, for which application is made, would permit color broadcasting. He explained that the Grant would provide 80 per cent of the needed funds, and that the remaining 20 per cent would be derived from generated income, with possibly a small portion being taken from equipment funds. In response to a question from Mr. Kennedy, Dr. Davison said that this would have no impact on operating funds.

Mrs. Phillips moved adoption of the Resolution. This was seconded by Mr. Morris and approved unanimously.

Resolution 1972-6

BE IT RESOLVED that the Board of Trustees authorizes the Treasurer of Ohio University to file an application with the Noncommercial Broadcasting Facilities Program of the U.S. Department of Health, Education and Welfare, and a separate related application under Section 214 of the Appalachian Regional Development Act, for financial assistance to obtain television broadcasting equipment in order for television station WOUB-TV to better meet educational and community needs.

VII. Selection of Next Meeting Date and Site

The next meeting will be in Athens at 2:30 P.M., Monday, March 13, 1972.

VIII. General Discussion--Roll Call of Members

Before he left, Mr. Kennedy remarked that under the heading of general discussion, he wished to express his delight at Dr. Culbert's statements about reorientation toward emphasizing teaching in promotion-tenure considerations.


Dr. Holzer expressed pleasure at the interesting presentations by deans. Mr. Johnson classed them as enlightening.


Chairman Baxter said the Board was indebted to Dr. Culbert and the deans for their fine reports.

You probably already know that Associate Professor Paul H. Wagner, School of Journalism, College of Communication is retiring at the end of the Fall Quarter due to extremely serious illness. Normally we would not process such a recommendation until much later in the year; however, the circumstances in this instance seem to warrant special consideration for early action.

Because of the precarious nature of Paul's life expectancy, and because of both the respect and concern that Paul's colleagues have for him, the School of Journalism is planning a special dinner party for him on December 12. Dean Wilhelm has asked if we might be able to announce the granting of emeritus status to Paul on that evening. Taylor and I explained the necessity for having not only your own approval but also that of the Board of Trustees. After a brief discussion, Taylor and I agreed that I would pursue the matter with you and request that Mr. Mahn be permitted to poll the appropriate committee of the Board by telephone prior to December 12.

I concur with the recommendation for emeritus status, and further, I support this request wholeheartedly.

I append, for your information, a copy of the letter you used in the past to inform persons of the award of the emeritus status.

Following final approval of this request, perhaps Peg Black should be asked to make a press release.



Dear Mr. Reese:

Mr. Tom Thomas of 4220 Morriwoather Rd., Toledo, Ohio, has written to me asking that I recommend him for re-admission to Ohio University for the winter quarter, 1972.

Mr. Thomas was a resident of Grosvenor Hall from September 1970 to January, 1971. In January, 1971 he was suspended from Ohio University because of turning in a false bomb threat. In the days following that incident I had the opportunity to counsel and talk with Tom on several occasions. He is now seeking readmission to Ohio University.

I recommend that his request for re-admission be affirmed for the following reasons:

- (a) It is my belief that Tom has matured a great deal since the incident ;
- (b) He has been sufficiently disciplined because of the incident, and to refuse his request for re-admission would be more punitive an act than remedial;
- (c) He has a strong desire to continue his college education here at Ohio University;
- (d) Tom had a strong grade point average (I believe it was higher than a 3.5) and, scholastically, he appreciates and values the opportunity for continuing his college studies.

Since I, as Resident Director of Grosvenor Hall, was instrumental in requesting disciplinary action against Tom at the time of the incident, I also feel obligated in urging that Ohio University now indicate its sense of justice and understanding by re-admitting Tom Thomas to this school. Further, I would be pleased if Tom was assigned to Grosvenor Hall for residency beginning the winter quarter.

I have spoken to several students from last year who knew Tom Thomas and they too have urged me to do whatever I can to encourage the Admissions Office to approve Tom Thomas' application for re-admission to Ohio University.



In mid-January of the 1970-71 academic year, I was suspended from Ohio University under Ohio House Bill 1219 after being convicted for placing a false telephone bomb threat to the Ohio University Security Police. I believe that, during the course of my trial and my hearing with the university, the point was made clear that the call was made as a prank (admittedly pointless and foolish) and that I had no "ill feelings" toward the school. Also, during the period of my suspension (during which I have been working to save money to eventually continue my education) I have found, through correspondence with and studies of various other colleges and universities, that Ohio University would most definitely be the best institution at which to continue my studies in the field of broadcasting. Because of this, and the fact that I did enjoy both the academic and social atmospheres at Ohio, I am genuinely interested in returning to Athens.


According to the law under which I was suspended, I believe that the school is legally allowed to accept my application for re-admission for the Spring Quarter of the present academic year. This is the date that I presently am considering as my objective for re-admission. However, before I make a formal application, I would very much appreciate the opportunity to speak personally with you about the various procedures necessary in my applying for re-admission under these circumstances. Quite frankly, I am rather confused at this point as to how I should go about it and I feel that qualified counseling would be my best path at this point.

I would sincerely appreciate your setting up an appointment, at a time convenient to you, for us to meet and discuss this matter. If you would do so, and notify me of the

time and date, I will make a point of being in Athens at that time without further correspondence, as my schedule is entirely flexible. Should you feel, however, that additional correspondence is necessary before such arrangements can be made, then feel free to notify me of your judgement to that effect also. My main concern is to re-enter the university as soon as possible and, naturally, your judgement supercedes mine in deciding how best to go about it.

I realize that the step that I have chosen to take will more than likely be a difficult one, but I honestly believe that a look at my academic record while I was at Ohio University will dispel any doubts that I am seriously concerned about my college education. I thank you for your time and consideration, and I will be looking forward to hearing from you.

Dear Mr. Nelson:

I am writing in support of the application of Thomas Leo Thomas for admission to Heidelberg College in Fall, 1971. Mr. Thomas was a freshman at Ohio University during the Fall Quarter and for a portion of the Winter Quarter of the present academic year. He had indicated a preference for Radio-Television as his ultimate area of concentration, and thus I was assigned to be his advisor.

My opinion of Mr. Thomas when we first met, and in subsequent meetings, was most favorable. He is an intelligent, enthusiastic young man and was an active, rather than a passive participant in the educational process.

Shortly after the start of the Winter Quarter, Mr. Thomas was apprehended by University Security for having phoned in a bomb threat in his dormitory. He was eventually convicted for the offense both under the "traditional" statutes which apply to such misdemeanors, as well as under the Ohio House Bill 1219, a recently passed measure which attempts to control the conduct of students at state-supported schools in Ohio. Under the provisions of the latter legislation, Mr. Thomas may not attend a state-supported school in Ohio for a period of one year.

I must admit that my evaluation of him was somewhat shaken after the above-mentioned incident, but in subsequent conversations it was clear that the telephone call was a non-political college prank, and that "he had learned his lesson." I remain firmly convinced that were it not for this most serious prank, and House Bill 1219, Mr. Thomas would have completed his college career at Ohio not only with a blemish-free record, but with academic honors as well. At no time did I perceive him to be an "activist" or a "radical" in the con-

temporary political sense of these terms, and I am sure that a personal interview with this young man will confirm this impression.

OFFICERS OF THE BOARD OF TRUSTEES

The President of Ohio University and the Officers of the Board of Trustees, elected on an annual basis, were elected at the July 20, 1970 meeting for the year ending June 30, 1971.

HYPOTHECATION OF FUNDS

Securities hypothecated by the respective depositories were found to be sufficient to meet the requirements of Section 135.16, Revised Code of Ohio.

THE OHIO UNIVERSITY FUND, INC.

The Ohio University Fund, Incorporated, a non-profit corporation, was established in 1945 as a gift receiving and holding agency for Ohio University. The Board of Trustees of the fund controls the use of contributions and gifts as specified by the donors. Unrestricted contributions are applied to uses for the benefit of the University.

Since this is a private, non-profit corporation, no audit was made of the records and accounts. The balance sheet summary and statement of operations included in this report were provided through the courtesy of the Treasurer.

AUDIT SCOPE

The examination was made in accordance with generally accepted auditing standards and accordingly included such tests of the accounting records and such other auditing procedures as were considered necessary in the circumstances.

Cash receipts and disbursements of the operating account, special account, residence and dining hall account, construction accounts, payroll accounts, bond and interest sinking fund account, bond and interest reserve account, repair and replacement reserve

Deposits of funds, fund transfers and journal entry documents were reviewed.

Insurance policies and surety bonds in force during the audit period were reviewed and scheduled.

Overseas petty cash accounts were not audited except in the amounts requested for replenishment.

Leases in effect during the audit period were examined and scheduled.

Financial transactions of projects supported by funds from Federal Government Agencies were examined.

On December 22, 1971, Mr. W. K. Minnick, Right-of-Way Agent for the State Department of Highways, met with me concerning requests for right-of-entry to seven (7) parcels of property belonging to Ohio University which will be affected by planned highway construction in the area. The projects include the extension of State Route 682 from Richland Avenue southeast to the Appalachian Highway, the relocation of Hooper Street, and the various ramp and drainage projects connected with this construction. Mr. Minnick also requested that we grant approval at the earliest possible date in order that the Department of Highways might proceed with their application for Federal Aid on sections of this highway project.

A thorough check of the drawings provided by Mr. Minnick and an inspection of the affected areas were made to ascertain what impact the granting of the requested right-of-entry would have on future plans for development of the areas. All problems were resolved except two, and these do not involve alterations to the property through which construction will pass, but rather they involve the closing and limiting of access to other property owned by Ohio University in the area. One parcel will become physically land-locked and the other could have access unduly restricted.

The land-locked parcel lies south of the relocated Hocking River in the South Green area. It contains approximately 20.0 acres of level land which definitely has potential for future development. State Route 682 extension through the area would eliminate our present entrance to the property. It is a limited access highway and all past and present attempts to obtain a variance that would give us access from the highway have failed. The only alternative available is to gain entry from the south by way of relocated Hooper Street. A suitable approach does exist but the property over which we must pass is privately owned. The Department of Highways is making a partial take of the private properties involved, and we have approached them about the possibility of obtaining additional sections of the private property which in turn could be made available to Ohio University for access purposes.

The area which will lose its present access contains approximately 26.0 acres and is located on the hill top east of the O.U. Inn. We presently own a parcel on Hooper Street which assures us access, but the Department of Highways requires the tract for the Hooper Street relocation project. It has, however, been indicated to us that following completion of construction the land would be returned to the City of Athens as public right-of-way, in

which case we could again make use of the area for access. We are currently checking to verify this fact, and also to ascertain that the terrain will not be altered in such a manner that access would not be possible. There is an alternate access but the alley is very narrow (12 feet) and considerable development would be required to make it passable.

In view of the fact that these problems have not been fully resolved to my satisfaction at this time, I recommend that the attached resolution be placed before the entire Board at the January 10 meeting. This resolution delegates authority to the Budget, Finance, and Physical Plant Committee for approval of the right-of-entry requests as soon as the aforementioned problems are resolved. This would provide additional time to assure that the interests of the University are protected, and, at the same time, provide for the granting of the requests at the earliest possible date.
