





I. Roll Call

The meeting was called to order by Vice Chairman Kennedy who presided in the absence of Chairman Baxter. Roll call showed a quorum to be present, consisting of Charles E. Holzer, Jr., Fred H. Johnson, Edwin L. Kennedy, William R. Morris, and Mrs. J. Wallace Phillips. Duncan M. Baxter, Don M. Casto, Jr. (whose term expired on May 14, 1972, but for whom a replacement has not been named), and C. Paul Stocker were unable to attend. (The ninth member, Wayne E. Brown, resigned effective May 1, 1972. A copy of his letter of resignation appears as Attachment 1.) Also present were President Claude R. Sowle and Secretary Robert E. Mahn. Vice President for Regional Higher Education Beaumont Davison and University Architect and Engineer Luverne Lausche were present to present reports.

II. Action on Minutes of Meetings of  
March 13, 1972 and April 14, 1972

The motion by Mr. Johnson, with second by Dr. Holzer, to approve the minutes of March 13, 1972 and April 14, 1972, as distributed, was adopted unanimously.

VII. New Business

A. Ratification of Founders' Citation

Awarded Dr. Robert L. Morton on April 21, 1972

President Sowle presented the following information and resolution. Mr. Johnson moved approval of the resolution. Mr. Morris seconded the motion, which was unanimously approved.

At an informal meeting with Board members on March 12, 1972, President Sowle proposed that Dr. Robert L. Morton be awarded the Founders' Citation at a dinner to be arranged at an early date. Mr. Johnson expressed the view that it was good to make this award to a meritorious faculty member, and recommended proceeding with the plan, with ratification at the next Board meeting. The other members present, namely, Baxter, Hölzer, Morris, Phillips and Stocker, concurred.

Resolution 1972 - 19

BE IT RESOLVED by the Board of Trustees of Ohio University that the Founders' Citation conferred upon Dr. Robert L. Morton on April 21, 1972 is hereby ratified:

HIS LOYALTY has enriched the University and has provided an example for all alumni and faculty to emulate. HIS SCHOLASTIC ACHIEVEMENTS during his forty-two years with the College of Education have brought great esteem to his college and his university. HIS PROLIFIC AUTHORSHIP is renowned world-wide and has broadened the perception of the University in academic environs. HIS PHILANTHROPY and HUMANITARIANISM have bequeathed to Ohio University, her faculty and students, an ideal in perpetuity with the endowment of the Robert L. Morton Professorships.

The name and the man, Robert L. Morton, shall persist and be honored as long as Ohio University shall endure.

In recognition of this beneficence, and by virtue of the authority of the Board of Trustees, Ohio University confers upon you its highest award, THE FOUNDERS' CITATION, with all the rights and privileges attached thereto.

B. Ratification of Naming of Speech Building Claude E. Kantner Hall

President Sowle presented the following information and resolution. Mr. Johnson moved approval of the resolution. Mrs. Phillips seconded the motion, which was unanimously approved.

At an informal meeting with Board members on March 12, 1972, President Sowle proposed that the Speech Building be named Claude E. Kantner Hall, as recommended by the faculty of the College of Communication and many friends of Dr. Kantner. There was consensus that this be done, with the announcement to be made at an April 28, 1972, College of Communication banquet in honor of Dr. Kantner, and that this be ratified at the next Board meeting. Concurring in this were the members present--Baxter, Holzer, Johnson, Morris, Phillips and Stocker.

Resolution 1972 - 20

WHEREAS, Claude E. Kantner, Ph.D., Professor of Communication, will be a member of the Ohio University faculty and administration for twenty-five years before retirement in June, 1972, and

WHEREAS, Dr. Kantner is an internationally recognized authority on Phonetics, having written numerous books and articles including a classic work of the field, Phonetics, and

WHEREAS, among his many professional activities he has been an outstanding Director of the School of Dramatic Art and Speech, served as Chairman of the Ford Foundation Study of Communication Curricula, and pioneered the development of the College of Communication--serving as its first associate dean,

NOW, THEREFORE, BE IT RESOLVED that in recognition of his distinguished career and his contribution to Ohio University and to the academic community, the Board of Trustees of Ohio University does hereby name the Speech Building on College Street the Claude E. Kantner Hall.

The recommendation to name the building in honor of Dr. Kantner and related documents appear as Attachment 3.

C. Appointment of William A. Phillips to Fill a Vacancy on the Ohio University-Zanesville Regional Coordinating Council .

Vice President Davison presented the following resolution, the acceptance of which was moved by Mr. Johnson, following a statement by him that he was personally acquainted with Mr. Phillips and endorsed his membership on the Council. Following a second by Mrs. Phillips, the motion was adopted unanimously.

Resolution 1972 - 21

BE IT RESOLVED by the Board of Trustees of Ohio University that William A. Phillips is approved for an eight-year appointment to the Ohio University-Zanesville Regional Council, replacing John Graham who resigned on February 4, 1972.

Information on Mr. Phillips appears as Attachment 4.

D. Emeritus Resolution

President Sowle reported that on May 11, 16, and 17, 1972, Vice President and Dean of Faculties Culbert had submitted to him the names of eighteen members of the faculty and administration recommended for emeritus status, according to the criteria followed in recommending to him those deserving of this status. He said he was endorsing them for the honor.

Mr. Morris moved approval of the following resolution, which Dr. Holzer seconded. It was adopted unanimously.

#### E. Chillicothe Phase II Construction Project

Vice President Davison stated that favorable bids had been received by the Department of Public Works on May 16. On May 18 the Department recommended the award of contracts (copy of letter and related materials appear as Attachment 6).

University Architect and Engineer Lausche answered questions about the bids. He expressed the hope that ground could be broken in three or four weeks. Mr. Kennedy reminded those present that the favorable bids meant that movable equipment eliminated from the project on the basis of preliminary estimates could now be restored.

Dr. Holzer moved approval of the following resolution to recommend to Public Works the awarding of the bids, which Mr. Morris seconded. The motion was approved with the following votes recorded on roll call: Johnson-yes, Morris-yes, Phillips-yes, Holzer-yes, Kennedy-yes.

Mr. Kennedy expressed the pleasure of the Board in approving a below-estimate bid.

Resolution 1972 - 23

WHEREAS, The Ohio University Board of Trustees at their May 13, 1971, meeting passed a resolution authorizing appropriate administrative officers of Ohio University to proceed with the planning, including the hiring of associate architects to prepare detailed plans, for the Learning Resources/Student Activities Center, Chillicothe Campus, Phase II at an estimated cost of \$1,000,000, and

WHEREAS, bids on the construction of the Learning Resources/Student Activities Center were opened on May 16, 1972, and the lowest total bids were found to be \$775,072, and

WHEREAS, The Director of the Department of Public Works of the State of Ohio, in a letter dated May 18, 1972, recommends acceptance of these bids, and

WHEREAS, these bids will result in a total project cost of \$1,000,000,

NOW, THEREFORE, BE IT RESOLVED that the following contracts for construction of the Learning Resources/Student Activities Center, totalling \$775,072, be recommended by the Board of Trustees to the Director of Public Works:

F. Athens Television Tower Replacement

Vice President Davison explained that the Ohio Educational Television Network Commission had contracted to erect a new television tower in the Athens area for the purpose of expanding the state-wide educational television system. An agreement to erect this tower on the site of Ohio University's existing tower is being negotiated. The new tower must be completed and in operation by September 10, 1972. Upon completion, the tower will become University property. No cost to the University is involved.

Mr. Morris moved that the following resolution be approved. Second was by Mrs. Phillips, and approval was unanimous.

Resolution 1972 - 24

WHEREAS, The Ohio Educational Television Network Commission, through funding provided by the Board of Regents, has been charged with the responsibility of expanding the state-wide educational television network, and

WHEREAS, plans call for the erection of television tower facilities in the Athens area as a requirement for implementing this expansion program, and

WHEREAS, it has been determined to the satisfaction of both Ohio University and the Ohio Educational Television Network Commission that dismantling of the existing tower owned by Ohio University and replacing it with a tower designed to meet the load requirements of both systems would be beneficial to both parties, and

WHEREAS, said tower replacement would be accomplished at no expense to Ohio University, and interruption of normal television programming can be accommodated, providing construction takes place between June 7, 1972, and September 10, 1972, and

WHEREAS, it is in the best interests of both Ohio University and the Ohio Educational Television Network Commission to proceed with the signing of an agreement at the earliest possible date in order to insure that construction can be completed during this period,

NOW, THEREFORE, BE IT RESOLVED that the Board of Trustees of Ohio University does hereby authorize the Budget, Finance, and Physical Plant Committee to approve the signing of said agreement between Ohio University and the Ohio Educational Television Network Commission when a final draft becomes available.

G. Resolution re \$24,700,000 General Receipts Bonds (Series 1972)

Mr. Kennedy stated that an ambiguity had surfaced which made it appear that the intent of the resolution approved at the April 14, 1972 meeting of the Board was not being carried out, in that the last three maturities are callable. Call before a ten-year period is unacceptable to bond purchasers. So, the intent of the resolution is to make clear that bonds are not callable for ten years, which will eliminate the possibility of a higher rate of interest on the last three years. Because there is a real competitive situation in respect to the bonds, the correcting resolution is offered. He commented that "with the market in a holding period with all eyes on Moscow" the new May 31 sale date might benefit us.

Mr. Morris moved that the following resolution designed to bring the original resolution in conformity with Board intent be approved. This was seconded by Dr. Holzer, and approved by roll call vote, with the following votes recorded: Johnson=yes, Morris=yes, Phillips=yes, Holzer=yes, Kennedy=yes.

Resolution 1972 - 25

RESOLVED by the Board of Trustees of Ohio University:

That the First Supplemental Trust Agreement and Series 1972 Resolution pertaining to Ohio University \$24,700,000 Receipts Bonds, Series 1972, Section 4 (e) and Section 5 (b) as adopted April 14, 1972 be amended as follows:

Section 4 (e) Redemption Terms and Prices. The series 1972 Bonds maturing on or before December 1, 1983, are not subject to redemption. Series 1972 Bonds maturing after December 1, 1983, are subject to call for redemption prior to maturity, in whole or in part and in inverse numerical order at the option of the Board of Trustees on June 1, 1984, or on any interest payment date thereafter at par and accrued interest to the date of redemption plus redemption premiums as follows:

3% if redeemed June 1, 1984, through December 1, 1988, inclusive,  
2½% if redeemed June 1, 1989, through December 1, 1993, inclusive,  
2% if redeemed June 1, 1994, through December 1, 1998, inclusive,  
1½% if redeemed June 1, 1999, through December 1, 2003, inclusive,  
1% if redeemed June 1, 2004, through December 1, 2008.

Notice of call for redemption of Series 1972 Bonds shall be given in the manner provided in the Trust Agreement.

Section 5 (b). Strike and delete therefrom the following:  
"not less than ten calendar days."

### VIII. Selection of Next Meeting Date and Site

Mr. Kennedy stated that a special meeting would probably be necessary in the summer. The next regular meeting will be held in Athens on Tuesday, September 12, 1972.

### IX. General Discussion--Roll Call of Members

President Sowle noted for the record what he felt Mr. Johnson would not report--the praise accorded Mr. Johnson at the dedication of the completed Hocking River Relocation Project. The project would not have gone forward without Mr. Johnson's efforts. It has more than proved its worth. All take pride in this accomplishment.

Mr. Kennedy stated that one sees the completed project, but still does not believe it. Mr. Morris added what he had said on another occasion: "God can make a tree, but only Fred Johnson can move a river."

Mr. Johnson expressed his pleasure at being on the Chillicothe campus. He moved that, at the end of a successful year, and the end of the second year of Mr. Baxter's chairmanship, the Board express appreciation to Mr. Baxter for his leadership. Also that it express appreciation to President Sowle for great leadership, and to faculty and administration for great accomplishment. There was a unanimous second and approval of the motion.

Mr. Morris expressed delight with the Chillicothe campus, saying that his visit to the Belmont campus, his home territory, made him ecstatic, and that Chillicothe rivaled it.

Mr. Morris continued his comments, stating that a report on leasing of the East State Street properties could not yet be made. The new statute, which is having its first application here, has many ramifications. Developers appear to be at a relatively close position of agreement and a report should be available within a reasonable time.

Mrs. Phillips had no comments other than to suggest that Mr. Johnson might assist in correcting the Chillicothe campus' flooding problem.

Dr. Holzer expressed pleasure at the opportunity of visiting the Chillicothe campus.

X. Election of Officers (Chairman of Board, Vice Chairman of Board, Secretary of the Board, and President of the University)

A. Chairman of the Board

Mr. Johnson moved the election of Mr. Kennedy to the Chairmanship for 1972-73. Mr. Morris seconded the motion, which was approved unanimously.

B. Vice Chairman of the Board

Mr. Kennedy moved the election of Mr. Morris to the vice chairmanship for 1972-73. Dr. Holzer seconded the motion, which was approved unanimously.

C. Secretary of the Board

Mrs. Phillips moved the election of Mr. Mahn as Secretary of the Board for 1972-73. Dr. Holzer seconded the motion, which was unanimously approved.


D. President of the University



The Board approved with considerable reluctance President Sowle's request that his salary for 1972-73 be the same as for 1971-72; also that his expense allowance for 1972-73 be a thousand dollars less than in 1971-72.

REPORT OF CAMPUS DIRECTOR TO THE OHIO UNIVERSITY BOARD OF TRUSTEES

In behalf of the Ohio University-Chillicothe Campus students, faculty and administration, it is my pleasure to welcome you to this campus. We are pleased to have you here. All of us on the regional campuses are delighted that you have decided to hold your meetings at our campus locations on a regular basis. Ohio University has been a pioneer in the establishment of regional campuses, and we are all grateful for the pioneering work under the administration of Presidents Baker and Alden. Under their administrations the dedicated work of Dean Gubitz, Dean Penson, and Dean Smith has come to fruition. The concern of President Sowle for regional higher education has been an inspiration to all of us. His appointment of Beaumont Davison as Vice President for Regional Higher Education has added additional commitment for a strong emphasis to regional higher education and for further development of the regional campuses.

I would like to give you a brief report on the development of this campus in terms of enrollment, curriculum development, facilities; student services, community relationships and inter-institutional relationships.

A number of you recall that after World War II, the Athens Campus was unable to accept all of the applications for admission and evening classes were begun at the old Chillicothe High School. In 1961 to supplement the evening program, classes were offered during the day at the First Presbyterian Church. Community involvement, through the Advisory Committee, led to gifts of money and land. In September of 1966, Bennett Hall, the present academic building, opened to provide two-year programs for students. In 1970, further action by the local Advisory Committee and the then Off Campus Academic Programs administration under Dean Smith's leadership resulted in the addition of both land and buildings to the campus complex. The interest and endeavor of the

local community were vital in the development of this campus, but the major impetus has always come from Ohio University-Athens. Administratively, academically, and physically, this campus is closely bound to the Athens Campus although it is evolving a unique identity within the framework of Ohio University.

We now have 22 full time faculty members and beginning this coming academic year 1972-1973 we will have three associate professors, six assistant professors and 13 instructors; three Ph.D's are included. Five of the faculty are near the doctorate and two are completing the final stages of their dissertations. In addition, we have nearly 20 part-time faculty members each Quarter, most of whom commute from the Athens Campus. The combined faculty teach approximately 115 sections of courses each quarter. In addition we have two graduate Master's programs administered on this campus but staffed by Athens departments in Business Administration and Industrial Systems Engineering. Presently we have approximately 602 undergraduate students and 105 graduate students. Our student body averages 550 full time equivalents or 70% carrying at least 12 hours or better. Over 200 students on this campus relocate to the Athens Campus for their junior or senior year during any one academic year. In addition over 500 individuals participated in our non-credit programs.

Our administrative structure is similar to that of the other regional campuses of Ohio University. The central administrative structure consists of the Director, and the Assistant Director, who is also responsible for admissions and registrations function. The Adult and Continuing Education administrator is responsible for credit and non-credit courses, short-term and workshop courses, the administration of the graduate programs and all other extension services of the campus. He also shares in facilitating many areas of community service

educational programs. An additional responsibility of temporary duration is to chair the Accreditation Committee and to oversee the preparation and coordination of all reports leading to accreditation by the North Central Association next year 1972-1973.

The Student Programs Director, who is in charge of student counseling and financial aids, is responsible for student organization and the administration of funds for the cultural programs. An additional responsibility has been the chairmanship of the Phase II Building Program.

The University has a fine library containing over 30,000 volumes administered by a Librarian and an Assistant Librarian.

With the acquisition of the Mount Logan Sanitarium properties last year, heavy responsibilities have been placed upon the Plant Maintenance Engineer, who is in charge of building and grounds supervision.

The Bookstore Manager and the Civil Service clerical and maintenance staff complete the organization of administrative functions on the campus.

The campus is governed by faculty administrative committees. In addition to the campus Director and Assistant Director, the campus is represented by a University Faculty Senate representative, Miss Monica Wyzalek, Assistant Professor of Mathematics. The Faculty has recently organized a Faculty Council to assist in the governance of the campus in academic affairs, to promote the development of the University in Chillicothe and to nurture the professional growth and stability of the faculty. The chairman of the Faculty Council is under the able chairmanship of Mr. Arthur Vorhies, Assistant Professor of Biology and Zoology. With the addition of the Student Program Director and the Adult and Continuing Education Specialist to various committees on the campus, the campus committees represent a broad spectrum of the University community.

Several major University committees have been active during the past year and will terminate their life upon completion of their functions next year. The Phase II Committee, under Mr. J. Stephen Phillips' chairmanship, has done an outstanding job of working with the architect and University planners in the design of the new facility. He has been ably assisted by Mr. William H. Allyn, our Librarian, and Mr. Merle V. Holcomb, our Building Maintenance Engineer and many others too numerous to mention.

The second major committee is the Accreditation Committee under Dr. Russell A. May's chairmanship alluded to earlier under the Adult and Continuing Education reference. This self-study project in preparation for accreditation by the North Central Association is already proving its worth by making us all study our weaknesses and our strengths as a regional campus of Ohio University. This agonizing process is going on at all of our sister campuses of Ohio University.

The third major committee has been the Law Enforcement Technology Program under Mr. Joe D. Pierce's direction, in preparing and designing the curriculum, which has now been approved by the University Curriculum Committee and the Board of Regents. Our Law Enforcement Technology is this campus's first attempt in Technical Education. We are now attempting to fill an appointment for the program with an academically qualified Director with faculty status. A second program, Real Estate Technology, has recently been approved by the University Curriculum Committee at Athens.

Our primary product is students, and we are proud of their academic performances. At the main campus, at other academic institutions, and in the world of work, faculty members and administrators at Athens and other colleges and universities have praised our students' performance and their work orientation in both classroom and at their work as undergraduate students in both business and academic offices of the University.

Feedback from our currently enrolled students both here and at the Athens Campus informs us that our faculty is a competent one and that our faculty members show a genuine interest in each student's academic growth.

It is to be hoped that ground breaking of the Phase II Project, the Learning Resources Center, will take place soon. The construction of the new facility will enable us to better use our present Bennett Hall by providing space for our new technical programs and other academic activities. In addition the new building will give our students a very much needed recreational area and also one happily housing a fine library.

Ohio University-Chillicothe faculty and administration are concerned about cooperative arrangements with other institutions in the area not only in higher education, but also in the area of vocational-technical programs. We have been encouraged and ably supported by Vice President Davison and Dean Smith. Currently, we are in the initial exploratory phase of discussions with the local Vocational-Technical District of Ross and Pickaway Counties. These cooperative arrangements and discussions attest to the wisdom of the regional higher education concept.

It is our belief that Ohio University's dedication to this concept bodes well for the future of higher education in Southeastern Ohio. The fact that our regional campuses are strong links in the chain is due in large measure to your support of President Sowle and his administration both at Athens and on the several regional campuses of Ohio University.

Again, let me express our appreciation in honoring us by your presence here and for giving us the opportunity of showing you another portion of your University.

✓ On April 28, 1972 the faculty of the College of Communication together with our former colleagues and graduate students from all over the country will honor Dr. Claude E. Kantner, Professor of Communication, as he retires from administration and his present position of Associate Dean of the College. A surprise banquet is planned during which it is our hope to present Dr. Kantner with a special book, Impressive by its thickness and weight, containing letters and telegrams from literally hundreds of former students who sense the unobtrusive excellence of this man and the way he has contributed to their lives as well as his field. It is our fervent hope that, with your help and approval (and, of course, with the approval of the Board), we might be able to announce that night the naming of the old Speech Building for Dr. Kantner.

✓ Very rarely do we have an opportunity to honor a man such as Dr. Kantner in a manner so appropriate. He came to Ohio University twenty-four years ago as an already renowned phonetician. Our School of Dramatic Art and Speech was small and unestablished. As its director, he developed it into one of the best widely recognized schools in the nation with a very rare -- even unique balance of theatre arts, inter-personal and mass communication, and hearing and speech sciences. I can tell you from very personal experience that he alone was the magnet which attracted a number of faculty and promising graduate students to Ohio University.

As a scholar, Dr. Kantner's contributions to his field are distinguished by quality and impressive with quantity. (Please see bibliography attached to Paul Boase memo of Nov. 24, 1971 for list of 36 major publications.) Now that more sophisticated research instrumentation is available, scholars in the field are proving as facts the ideas and theories Dr. Kantner hypothesized without benefit of such instruments years ago.

As a person, Dr. Kantner is known as the easiest of human beings to talk to. He combines a capacity for understanding with both wit and wisdom. I came to him one day to seek his advice on a serious administrative problem and asked if he had an administrative panacea in his dealings with people. His eyes twinkled, and he replied, "My job has been to make the insecure feel more comfortable and make the comfortable feel insecure."

On Thursday, December 16, 1971, the Senior Administrators unanimously recommended naming

the building for Dr. Kantner with the idea "that the announcement would be made at ceremonies in connection with Dr. Kantner's retirement from his administrative position." I understand that Vice President Hecht will present a plan for naming of buildings to the Board in May rather than in March as originally thought. Therefore, I request informal consideration of this proposal regarding Dr. Kantner in March, hopefully with ratification at the May meeting.

The following statement written by Dr. Gordon Wiseman was enthusiastically endorsed by the committee established to plan appropriate honors for Dr. Claude E. Kantner.

Dr. Claude E. Kantner, Associate Dean of the College of Communication, will retire from his administrative duties on July 1, 1972, after 25 years of faithful and dedicated service to Ohio University. It is recommended that the present Speech and Theater Building on College Street be named the Claude E. Kantner Hall in his honor. It is felt that Dr. Kantner not only deserves this honor but also that this is an advantageous time to name a building after a teacher-administrator.

Dr. Kantner came to Ohio University in July, 1947, as Director of the School of Dramatic Art and Speech. He came as director of a school that included just dramatic art and speech, which was housed in five buildings and included eight faculty members. Under his leadership the present Speech and Theater Building was planned and built and dedicated in 1951.

With many individuals this kind of success would have been cause for relaxation but not so with Dr. Kantner. His uncanny ability to plan for the future was evident in the early years of his leadership.

Dr. Kantner's ability to dream dreams and then to implement those dreams provided a leadership that helped the School to grow in every way. He carefully selected new faculty from various schools so that all philosophies would be represented. His constant prodding and encouragement to young members of the faculty to not only finish the Ph.D. degree but to get it in new areas of communication readied the School so that when the Ph.D. program was introduced at Ohio University, the School of Speech was the second area invited and encouraged to develop a Ph.D. program. As funds were made available for new areas, i.e., Television and Organizational Communication, Dr. Kantner had already planned so well that the School was able to accept the new challenges.

Perhaps equally important has been his ability to initiate new programs

so that at all times Ohio University was ahead of the field. This reputation has attracted worthy graduate students who have gone out to become leaders in all areas of the schools represented. Dr. Kantner's ability to recruit the right students at the right time has enhanced this success.

Dr. Kantner's own personal dedication and depth of scholarship served as a model so that he lead by both precept and example. He was always willing to give of himself and each goal reached was not a stopping place but a stepping stone to new and greater things. The concept of the new College of Communication was initiated under his leadership and came to fruition in 1968. Speech at Ohio University has been under the close leadership of Dr. Kantner. Others have made their individual contributions but Dr. Kantner has given the direction. It is for these reasons, as well as many others, that we feel that the present Speech and Theater Building should be named Claude E. Kantner Hall.



If all emeriti recommendations for this year can be submitted to me by Taylor not later than Monday, May 15, I shall see to it that they are placed on the agenda for the Board meeting later this month. If the May 15 date is too early, the recommendations will then be submitted to the Board in late Summer or early Fall.

SUBJECT Procedure for Award of Emeritus Status

In reply to your lengthy handwritten footnote dated April 15, 1972, on the bottom of Dr. Pullen's memo to you of April 13, 1972, we offer the following observations and suggestions. Attached also is a tabulation of Emeritus Awards.

At the end of the faculty section in the campus directory (on pages 47 and 48) is a listing of living Emerti faculty and staff, consisting of both faculty members as well as non-faculty members, e. g. Butch Grover, Athletic Director Emeritus, Al Gubitz, Dean Emeritus, John Baker, President Emeritus, etc.

In the academic area the procedure for the granting of emeritus status works as follows:

a) In March or April of each year, the Vice President and Dean of Faculties requests each unit within the academic area to review all of its personnel for possible recommendation for award of emeritus status. The unit head forwards his recommendations to the appropriate dean.

b) The dean reviews the recommendations of the subunits and forwards his recommendations to the Vice President and Dean of Faculties.

c) The Vice President and Dean of Faculties reviews the deans' recommendations and forwards his own recommendations to the President.

d) After review of the Vice President and Dean of Faculties' recommendations, the President forwards his recommendations to the Board of Trustees for consideration and award of emeritus status.

At each level of review and recommendation, a judgment is made as to whether the individual concerned has earned emeritus status. This judgment is based upon 1) length of service, 2) quality of service, and 3) significance of total contributions to the University. No one automatically acquires emeritus status, even if he serves the University for 50 years.

procedure

I would suggest that where individuals in areas other than the academic area are thought to deserve emeritus status the recommendations flow upward to the appropriate senior officer and that he forward his recommendations to the Vice President and Dean of Faculties. The Vice President and Dean of Faculties would therefore be in the position of consolidating recommendations before they went to the President and he would furthermore be in a position to evaluate the contributions of people in areas other than the academic area in terms of the main stream of emeritus awards--i. e. those involving faculty members.


Replies to the three points in Taylor Culbert's memo of April 24 follow:

(2) Professor Appel has performed superbly during the years I have known her, and I suspect that the qualities I have observed in her have been characteristic of her entire association with Ohio University. She is conscientious, honest and loyal. She thinks of students first -- what is in the students' best interest. She places her faculty colleagues next. Upon completion of the present academic year Professor Black will have completed 22 years of service to Ohio University. From September, 1949 - July, 1967 he served as the Chairman of the Mechanical Engineering Department.

2. Quality of that Service and Significance of his Total Contribution to the University

Professor Black has had a long and distinguished career both as a teacher of machine design and as an engineer. He has been responsible for developing and teaching the following courses: Metal Processing, Machine Design I, Lubrication and Bearing Analysis, and Special Investigations. In addition, he is responsible for establishing the Mechanical Engineering Department here at Ohio University in 1949. He was hired from Cornell University where he had been full professor of machine design.

SUBJECT Departmental Nomination of Laurence V. Calvin for Emeritus Status.

At our faculty meeting on May 1, 1972 a general discussion of evidence supporting our nomination, in accord with the memo from Vice President Culbert relating to form, led to the following:

1. Length of Service: Mr. Calvin has served twenty five years in our department. He was appointed as an instructor in 1947; was promoted to assistant professor in 1949; and was promoted to associate professor in 1971.
2. Quality of Service: Several instances can be cited where Mr. Calvin served well, according to particular need at the time. Examples are the writing of a departmental history at the time establishment of a chapter of Epsilon Pi Tau was being considered; serving as co-trustee of this fraternity for several years on campus; revising departmental courses as offered through correspondence study; and active involvement with the University College Committee at the time two-year associate degrees were first made available at Ohio University.

The area in which Mr. Calvin excelled was in his personal relationships with individual students. He served several years as a University College Advisor for students with special academic problems. Faculty generally report that whenever they encounter former graduates, the person most often inquired about is Mr. Calvin.

3. Significance of Total Contribution: Our faculty are in agreement that the influence of Mr. Calvin on student and faculty morale will be a most difficult factor to replace. We cannot state in quantitative terms how significant the words of an impressed graduate can be toward increasing the percentage of new students electing to study in our department;

yet we know that this factor is operating, and that Mr. Calvin helped "weigh the scales" in positive direction. The importance of a unique person like Mr. Calvin in an academic environment does not reveal itself through standard measurements as normally employed. His influence is felt by, and is most significant to, the individual student with whom he is working. If we are here to serve the student in his professional development; then faculty who get personally involved with the individual and his problems are significant.

It is the opinion, and recommendation, of the Faculty in Industrial Technology that Mr. Calvin deserves emeritus status. We trust that this recognition will be given.

The Department of Organizational Science, College of Business Administration, unanimously recommends that Dr. E. T. Hellebrandt, Professor of Economics and Management, be granted the title "Professor Emeritus of Economics and Management."

Throughout his tenure at Ohio University, Dr. Hellebrandt has been an innovative leader in the education of students. He taught the first Management class offered at Ohio University. He initiated and formed the Department of Management. He has served as a sensor for the academic community, identifying educational needs and initiating courses to meet those needs. He has been the innovator as well in teaching methods. As new techniques of learning have been developed, Ted Hellebrandt has always been one of the first to experiment with them.

Dr. Hellebrandt has also been a leader in graduate education in Economics and Business. He served on the original Graduate Council of Ohio University in the 1930's. He was instrumental in the development of the Master of Business Administration degree which was approved for the College of Commerce in 1955. He has directed more than forty Master's theses and has consistently served on Ph. D. dissertation committees in the Colleges of Education and Communication.

Along with his duties as a teacher and administrator, Dr. Hellebrandt has functioned as a researcher. His first research report, other than his Ph. D. thesis, was published in 1934 in the Journal of Land Economics and Public Utilities. His most recent research effort is being refereed for publication at the present time. The breadth of his scholarship is evidenced by his publication with journal articles appearing in such varied journals as the American Journal of Physical Medicine, Harvard Business Review, and the Journal of Social Psychology. In addition, he is the developer and principal author of the General Business Management Simulation, a business game currently in use here in the Business Policy course.

Dr. Hellebrandt has represented Ohio University with distinction in relationships with its various publics. He has served as a consultant to more than 100 different organizations in North America, Europe, South America and Asia. He started the Ohio University student chapter and the Athens area chapter of the Society for Advancement of Management and served as a national governor and regional vice president of that organization. He pioneered in the education of practicing managers in the Midwest. He initiated the Ohio University offerings of management development programs to industry in the surrounding area. Whether serving in board rooms or with first-line foremen, in the U.S.A. or abroad, he has served with distinction and has enhanced the name of Ohio University.

In response to the three items set forth by Taylor Culbert in his memorandum to budget heads regarding emeritus status, I submit the following concerning Dr. Samuel I. Hicks:

1. Dr. Hicks came to Ohio University in 1958. He is completing 13 years of service with Ohio University in the College of Education.

2. During Dr. Hicks' tenure with the College of Education he has carried out many important and valuable services. Among these are the following:

a. Teaching. Dr. Hicks has taught many courses at the graduate level in the field of educational administration. He has an excellent reputation among the students as being a stimulating and challenging teacher.

b. Guiding Graduate Research. Dr. Hicks has served on the dissertation committee for many doctoral students, both within the Department and outside, and he has also served as the major adviser for quite a number of our Ph.D. candidates. Dr. Hicks has always expressed a great interest in the field of educational research and has performed a vital role within the College in this regard.

c. Leadership Responsibilities Within The College and Department. Dr. Hicks has served in the following important leadership roles within the College: Chairman of the College-wide Graduate Committee; Chairman of the Department of Educational Administration; and Director of the Center for Educational Research and Service. Dr. Hicks was here at a crucial time during the developmental stage of the doctoral programs in the College of Education. In his capacity as Chairman of the Graduate Committee, he had a leadership role during that time.

3. Because of my limited tenure at Ohio University, I am not aware of all of Dr. Hicks' contributions to the total University. One contribution, however, is very significant, I think, and that is his three years of service as the Director of the Institute of Education at Ahmadu Bello University in Northern Nigeria. The position of Director of the

Institute of Education is a very important one so far as education in Northern Nigeria is concerned. Dr. Hicks served as Director at the time that Albert Ogunsole was at Ohio University working toward his doctorate. Dr. Ogunsole is now Director of the Institute of Education. It seems to me that this activity abroad, as well as Dr. Hicks' affiliation with such national organizations as the Association of School Business Officials, has helped greatly to enhance the favorable image and visibility of Ohio University.

I should indicate also that Dr. Hicks has been very highly regarded by public school administrators in Ohio. This respect has come about through his directing surveys in many school districts in Ohio, his teaching, his reputation as an effective administrator in public school systems before coming to this University, and through his own interest in simply knowing the men and women in school administration today.

In conclusion, as Chairman of the Department of Educational Administration, I heartily recommend Dr. Hicks for the award of emeritus status upon his retirement from Ohio University.

SUBJECT Emeritus Recommendation for Miss Mary Leonard

1. Miss Mary Leonard has taught at Ohio University since 1937 and received tenure status in 1940. She was promoted to full professor in 1971. During these past 35 years, Miss Leonard has taught children's classes at the Laboratory School and college classes in art education. She also served two years (1960-1962) in Nigeria as a member of the educational team from Ohio University; advising Nigerian educators about art education.
2. Her work in art with children, and in art education, is of the highest quality. Her contribution to children, college students, and art majors has been outstanding. This reaction has been expressed many times by the children themselves, parents of children, her colleagues in art education, and her college students.
3. Miss Mary Leonard has contributed to art in many different ways. In 1958 she authored a pamphlet Let's Create, for elementary art teachers, and while in Nigeria, co-authored (with Adeyemi Adenuga) a book, Art for Nigerian Children. She contributed regularly to the Teachers Monthly, a Nigerian teachers' magazine.

Miss Leonard served as acting chairman of the art education segment of the School of Art from 1950-1967. She also served on the executive committee of the College of Fine Arts during Mr. Clifford McCarthy's sabbatical.

She has organized workshops locally for teachers in Ohio and has been a consultant in workshops in other Ohio schools. Exhibits of her personal art work includes local showings and various showings in the state. She has also sponsored and directed many exhibits of children's art work.

Miss Leonard served for many years on the State Certification Committee, and on a committee for the development of the art curriculum for the State Department of Education.

I enthusiastically recommend Miss Mary Leonard for Emeritus status because of her productive and profound professional life at Ohio University.



SUBJECT Paul O'Brien--Emeritus Status Recommendation

In response to your note to me concerning vital information which you need to support my recommendation that the late Paul O'Brien be given emeritus status, I submit the following:

- (1) Paul O'Brien served the University from 1946 to 1971 on a full-time basis. During that period, he served as controller, treasurer, vice president for business affairs and secretary of the Board of Trustees. In addition, he served as a consultant to the vice president for development and the vice president for university relations with major assignment in legislative liaison activity.
- (2) The quality of Mr. O'Brien's service is a matter of record during the forties, fifties and early sixties. Due to health conditions, Mr. O'Brien had to decrease his senior officer responsibilities in the latter sixties and devoted the remainder of his full-time tenure to the position of secretary of the Board of Trustees. The appreciation luncheon given by the Board of Trustees at the time of Mr. O'Brien's retirement is an indication of the high esteem in which he was held and the appreciation the University had for his service.
- (3) Mr. O'Brien served under three presidents and was a senior officer during the period of the University's greatest growth in enrollment, faculty and physical facilities. There was never any doubt as to his loyalty to his Alma Mater, and he gave the same attention to the assignments given to him by the three presidents and the members of the Board of Trustees.

These are the minutes of the meeting of the Ohio University Board of Trustees held at the Ohio University Inn in Athens, Ohio on Friday, June 11, 1971. Chairman Baxter called the meeting to order at 2:35 p.m. with the following members of the Board of Trustees present: C. Paul Stocker, Wayne E. Brown, Fred H. Johnson, Edwin L. Kennedy, Mrs. J. Wallace Phillips, and Fred W. Crow, Jr. In addition to the Trustees, also present were: President Claude R. Sowle, Provost Robert L. Savage, Vice President for Educational Services Richard C. Dorf, Treasurer John F. Milar, and Secretary to the Board of Trustees Paul R. O'Brien.

Mr. Kennedy moved, seconded by Mrs. Phillips and unanimously carried that the minutes of the meetings held on April 12, 1971 and May 13, 1971 be approved as distributed by the Secretary.

Dr. Meno Lovenstein, author of the historical book entitled The Decade of the University: Ohio University During the Alden Years, presented each of the members of the Board of Trustees a leather bound copy of this book. The Trustees expressed their thanks for this book and instructed the Secretary to write a letter of appreciation to Dr. Meno Lovenstein.

Fred Johnson then presented a resolution of appreciation to Paul R. O'Brien, who is retiring as Secretary to the Board of Trustees on June 30 of this year. It was moved by Mr. Johnson, seconded by Mrs. Phillips and unanimously carried that the following resolution be adopted:

WHEREAS, Paul Raymond O'Brien, Class of 1932 and a native of southeastern Ohio, is retiring as Secretary of the Board of Trustees of Ohio University, a position he has held for twenty years, and

WHEREAS, prior to his return to Ohio University as controller in 1946, he served his country during World War II as an officer for three years, as an auditor for the State of Ohio for nine years, and as an accountant in private business for three years, and

WHEREAS, he held the positions of treasurer and of vice president for business affairs during the University's greatest growth period,

NOW, THEREFORE, BE IT RESOLVED that the Board of Trustees, on behalf of Ohio University, does hereby officially commend Mr. O'Brien for twenty-five years of loyal and devoted service to the University and to three University presidents; and on behalf of all the Trustees he has served, does express grateful appreciation for his personal devotion to them.

The Chairman then called on President Sowle for his report. President Sowle reported as follows:

President Sowle reported that he believed we have had two years of rather solid progress despite the dramatic problems of student unrest during his first year as president.


There is still much to be done and the most serious immediate problem is the 1971-72 budget. He explained to the Trustees that the budget they had approved previously contained an increase in expenditures of 3.3 million. Governor Gilligan's budget as submitted to the Legislative contained an increased appropriation of 1.6 million for Ohio University. The House later cut this recommendation to 1.4 million when they passed the appropriation bill. The House approved does permit an increase in fees of \$90 per year, which with the 1.4 million increased appropriation will provide approximately 3.3 million for the 1971-72 fiscal year.

The President reported there are several bills that have been introduced in the Legislature providing civil service pay increases. As presently
