WHAT TO EXPECT FROM AN ADVOCATE

CONFIDENTIALITY

What you share will be kept private and confidential, barring any legal exceptions or your permission.

RESPECT AND EMPATHY

Advocates are there to listen, not to pass judgment or investigate. We use the *Start By Believing* approach.

FREEDOM TO CHOOSE

Advocates help you make informed choices, but those choices are yours and will be respected.

Regardless of when an assault occurred, or when the dating/domestic violence or stalking began, the Survivor Advocacy Program is here to serve you and help you make informed decisions.

A FEW THINGS WORTH KNOWING

WHEN SEEKING SERVICES

If you wish to seek medical attention or receive a SANE (forensic) exam, an advocate can accompany you to OhioHealth O’Bleness Hospital. A SANE exam can be conducted any time within 96 hours of a sexual assault and is free of charge to the survivor.

If you choose to report to law enforcement or ECRC/Title IX, an advocate can provide support throughout the process.

If you choose not to report the incident or seek medical attention, you can still utilize advocacy services for support, crisis intervention, accommodations, referrals and workshops.

WHEN SOMEONE DISCLOSES TO YOU

- 1 Ask if the survivor is safe or what they need to feel safe.
- 2 Let the survivor guide the conversation and level of disclosure — do not press for details.
- 3 Do not make promises that you cannot keep.
- 4 Trauma may cause a survivor to act in unexpected ways or have limited memory. There is no “right” or “wrong” way to act after a traumatic incident.
- 5 Remember that university employees are mandated reporters.
